TRADE COMPLIANCE POLICY DEVELOPMENT

Whether in an audit by government authorities or in a certification review by a qualified ISO review body, the existence of a comprehensive, up-to-date set of written trade compliance policies is essential for ensuring a positive outcome.

Many companies have had their financial and business processes certified under the ISO quality standards.

The key to achieving certification is having standard, documented processes in place which meet specified acceptable requirements.

The documentation is a crucial part of

proving that minimum standards have been met but also serves as a guide for employees and service providers engaged in the company.

It delivers a basic assurance that the company is aware of its compliance obligations and has thought through the operational implications of them.

Survival of a trade compliance audit, approval for and maintenance of self-assessment programs, and achieving the "green lane" status of programs implemented under the auspices of the WCO's SAFE Framework all have one major underlying pre-requisite in common: adequate documentation of compliant practices which shows that relevant policies have been developed

and tailored to the company's operations and are actually in use within the company.

SUPPLY CHAIN RISK ASSESSMENT

The US C-TPAT program, the EU and Japan's AEO programs, Singapore's Secure Trade Partnership and New Zealand's Secure Exports Scheme are just a few of the growing number of supply chain security programs sponsored by governments for voluntary participation by companies engaged in international trade.

These programs are based on the principle that companies which demonstrate compliance with recognized security (and in some cases customs compliance) standards, and which have undergone a validation process, qualify for recognition as a secure trader and are eligible for a number of trade facilitation programs.

Many governments are also working

on mitigation of risk in the international supply chain, whether by mandatory security requirements for port operators, by secure trade lane pilot programs, or by voluntary programs for traders.

The Trusted Trade Alliance team is well-versed in the requirements of these programs and is experienced in implementing them in some of the largest companies operating in the ports globally.
